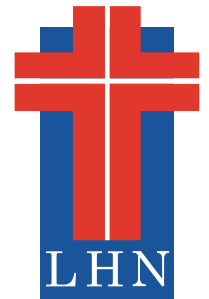

The Lutheran Education Association of Houston, endeavoring to make Christian education affordable for all families who seek it, has made provisions for tuition assistance to those families of proven need.

Through the B. M. Woltman Foundation and Torchbearer Scholarships a set amount of funds for tuition assistance is available to assist parents with their obligations to finance their children's education.

TUITION ASSISTANCE APPLICATION INSTRUCTIONS

As you fill out this application, it is important to provide all the information requested to avoid delays in processing. In order for the Tuition Assistance Committee to appraise your need for assistance, dollar amounts must be provided for all taxable and nontaxable income for the previous year. **[A copy of your 2006 IRS tax return with all schedules and supporting W-2's, 1099's, etc., must also be included before any tuition assistance will be considered.](#)** Please outline all income sources and expenditures, noting any emergencies or special situations which make tuition assistance necessary.

[This information is confidential](#) and will only be reviewed as the tuition aid request is considered. It is understood that in keeping with proper business procedures the Tuition Assistance Committee may obtain a local credit standing from a credit bureau in Houston.

Things to be remembered as you complete this application:

1. Enter all amounts in dollars; omit cents.
2. Do not leave anything blank - enter a zero (0) if no other entry is appropriate.
3. If parents are separated or divorced, this application should be completed by the custodial parent and the custodial parent's spouse. The non-custodial parent may also be required to complete a separate application. If someone other than a parent is financially responsible, that person should complete the application and explain the relationship.
4. You **must** complete the question indicating how much you feel you can afford to pay.
5. **The school maintains that the primary responsibility for financing education rests with the parents/guardians of the student.** Accordingly, in calculating a family's ability to contribute to their child's cost of education, a reasonable amount of income may be imputed for a non-working spouse. Non-working parents who are caring for pre-school children, a disabled family member, an ill family member, or are home-schooling may be exempt.
